### **STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS**

In 2006, we continued to bring our services to adolescents and young adults in the greater Los Angeles area. In the past, we served two major populations. The first are the young people who hang out on our main thoroughfares making their living as prostitutes and drug dealers. We have achieved our goal with this population because there were no more prostitutes working the streets of our area. After ten years of moving an average of twenty-five people off the streets and on to a better life, we have declared success and now are concentrating all our efforts on our other population.

Our second population is those that live at home and socialize in the West Hollywood club area. Most of these young people are living at home and because their parents do not know their sexual orientation -- they are living double lives. The stress of doing this makes them the most vulnerable kids for suicide and drug addiction. We provided our "Counseling On Demand" services which include: outreach to prospective clients in their environment by our social workers, follow-up counseling, substance abuse treatment, job counseling, referrals, and 24/7 access to a social worker that the youth knows and trusts.

Because of recent cuts in funding, we have been forced to totally review how we could continue to provide our much needed services, and converted our operation to an all volunteer effort. Our assessment of our services showed that the most used and needed service has been our 24/7 phone hotline that provides masters level counseling to at-risk youth. We are the only agency in our area, and one of the few nationwide that provides such a service. We regularly get referrals from other hotlines staffed by para-professionals when their cases are too much for them to handle. We also get many calls from at-risk youth from all over the country that find us on the internet. We also provide in-person counseling to youth and their parents. Our plans for the next year are to further develop and expand our telephone hotline service.
